Indications and Doses of Different Progestins		
Indication	Progestin	Usual Dose
Hormone Therapy	MPA	2.5 mg* daily continuously 5-10 mg for 12-14 days
	Micronized Progesterone (Prometrium)	100*-200*mg HS continuously 200-300*mg for last 12-14 days of cycle
	Norethindrone acetate* (Micronor, Norlutate)	0.35-0.7 mg daily continuously
Secondary Amenorrhea	MPA	5 – 10 mg daily for 12-14 days every month

	Micronized Progesterone*	200 mg daily for 10-14 days every month
	Norethindrone acetate	2.5 to 10 mg starting with the fifth day of the menstrual cycle and ending on the 25 <sup>th</sup> day.
<b>Dysfunctional Uterine Bleeding</b>	MPA	5-10 mg for 10-14 days
	Norethindrone acetate	2.5 to 10 mg starting with the fifth day of the menstrual cycle and ending on the 25 <sup>th</sup> day.
<b>Metastatic Endometrial Carcinoma</b>	MPA	200-400 mg/day is the usual dose. See CPS for more information
	Megestrol acetate (Megace OS)*	160-320 mg daily
<b>Metastatic Breast Cancer</b>	MPA	400 mg daily, given in divided doses. See CPS for more information
	Megestrol acetate*	40 mg QID

\*Not a labeled indication or dose

**\*\*Note: Prometrium® is usually EDS on the Saskatchewan Drug Plan. However, it is full formulary for two months during the manufacturer shortage of MPA tablets.**

**Alternatively, consider other combination products (usual doses):**

- Oral:
  - Activelle one tablet daily
  - Angeliq one tablet daily
  
- Transdermal:
  - Climara Pro 45 mcg weekly
  - Estalis 50 mcg twice weekly
